

**AGREEMENT BETWEEN MBD KOSHER CERTIFICATION SERVICES LTD AND  
RAINBOW DUST COLOURS LTD, UNIT 3-6, WARD STREET, LOSTOCK HALL, PRESTON PR5 5HR**

**1<sup>st</sup> Oct '17 – 11 Tishri 5778**

1. This agreement is regarding the following 11 NON FOOD and FOOD DECORATION ranges listed below:
  - 1) Liquid Colour
  - 2) Glitter
  - 3) Paint
  - 4) Confetti (excluding pink coloured confetti)
  - 5) Lustre
  - 6) Cake craft pens
  - 7) Powder colour
  - 8) Progel
  - 9) Non Edible Sparkle glitter
  - 10) Cake craft brush – Metallic & Matt
  - 11) Essentials range [Edible Glue, Dipping Solution, Glaze Cleaner, Gum Tragacanth, Tylo Powder, Paint Creator & Glycerine – retail packed]
2. The production and packaging may only take place at their manufacturing site; Units 3-6 Ward Street, Units 4-6, Preston PR5 5HR.
3. No production or packing may take place out of house.
4. The approved list of the twenty six [26] raw materials and suppliers is on the following page. No other ingredient or supplier may be used for the above Kosher ranges. All ingredients from the listed suppliers must be found on their corresponding Kosher certificate.
5. No Shellac or Carmine may be used in any of the above twelve ranges and products.
6. The Sugar Crystals range and the Glaze in the Essentials range are not Kosher certified and may not be marked or marketed as Kosher.
7. 'RDCL' will not make any changes regarding ingredients, suppliers or equipment without written consent from the MBD.
8. 'RDCL' will maintain on record up to date Kosher certificates from all of its suppliers.
9. The MBD will treat as confidential any information received from 'RDCL' regarding their ingredients, suppliers and manufacturing procedures.
10. 'RDCL' may use the approved logo of the MBD on their Kosher certified products.
11. The logo may not be used on any other item sold by 'RDCL'.
12. The MBD will visit 'RDCL' at least twice a year to confirm that the details of the agreement have been adhered to and to check any relevant paper work.
13. 'RDCL' will not allow any individual or representative of any Kosher Certification Organisation to inspect them to determine compliance with Kosher laws without the written permission of the MBD.
14. The MBD will inform interested parties that the range of products noted above are available from 'RDCL'.
15. The MBD will invoice 'RDCL' £840 for the annual certificate plus the cost of the visit, travel etc.
16. This certificate will be valid for one year and subject for renewal at its expiry.
